Limited Company Membership: Companies based in the United States that service the spirit industry by conducting competitions and/or camps on a **limited** basis. (Committee recommendation and board approval required)

State Association Membership: State and local coaches associations.

Gym Membership: All Star Gyms and Recreation Leagues.

Judge/Individual Membership: Individuals who have been or would like to be on the competition judging circuit and/or speaking circuit.

International Company Member: Companies whose home offices are based outside the United States and that service the spirit industry by conducting competitions and/or camps outside the United States only.
